


#### 2022 Project – Streets

The Hidden Pines neighborhood is in for some street improvements! Bituminous replacement is scheduled for portions of 3<sup>rd</sup> & 4<sup>th</sup> Avenue NE, and portions of 11<sup>th</sup> & 12<sup>th</sup> Street NE. Additional work includes storm sewer repairs, some draintile installation, and spot replacement of the concrete curb and gutter.



#### **New Water Bill**



You may have noticed that your water/sewer billing is now a full sheet mailed in an envelope. After many years of the postcard billing not being received by residents, we've made this change while switching to a new utility billing program.

#### Billing items that have not changed:

Please allow 3-5 days for mailing. Payments should be postmarked by the 13th to avoid a late fee.

Alternatives to mailing your payment include signing up for Direct Payment (no fee sign up!) or to pay with your credit/debit card (minimum \$3 convenience fee). Both can be accessed at <a href="https://www.cityofmilaca.org/payments">https://www.cityofmilaca.org/payments</a>. Or just drop off your payment at City Hall! Here are some of the changes, and how we feel it will benefit you as our customer:

#### **Message Box**

This is a great way to notify you of any events, whether it be holiday hours, winter parking, or even just to wish you a happy day.

#### **Customer Number**

Your account number is now an easy-to-remember 8-digit number! If you are paying via bank generated check, or online at <a href="https://www.cityofmilaca.org/payments">https://www.cityofmilaca.org/payments</a>, please include this number in the 00-0000-00 format.

#### **Bar Graph**

This box shows your monthly water/sewer usage. Please note that there's only a couple months' worth of data right now due to the switch to our new utility billing platform.

#### **Direct Payment**

This text shows that you do not have to send payment in; that your bank account will be automatically deducted. If you are signed up for Direct Payment and this is NOT indicated on your water bill, please call City Hall at (320) 983-3141. If you'd like to sign up for Direct Payment, the form can be found at

#### **Meter Detail**

While not new, the Meter Detail box located on the lower portion of your bill is a great feature as well. You can see the dates the meters were read, the number of days in the billing cycles, your readings, and usage.

#### **Bottom Portion**

This portion of the bill should be submitted with payment. We hope to have it perforated in the near future to make it easier to be included when you pay.


#### **DOG LICENSES**

Police Department.

Remember to license your dogs! The City of Milaca requires that all dogs over the age of four

licensed and registered with the city. Dog licenses purchased now will be valid through December 31, 2023 (two years). Licenses are issued by the Milaca Police Department, City Hall, 255 1st St. E, Milaca, (320) 983-6166. License fees are \$15 each for the first two dogs and \$30 for a third dog. There is a three dog maximum within the city limits. Please bring proof of current rabies/distemper vaccinations at the time of registering. Registering your dog can help to keep your dog safe should it become lost. Dogs running loose are contained by the Milaca Police Department. If your dog is licensed/registered we can contact the owner so your dog can be quickly returned home. Dogs that are unlicensed are taken to animal control which can result in costly fees to get your dog released. Licensing your dog helps you and the

#### **PARKS**

#### **Rec Park**

The hockey rink and free skate area at Rec Park are officially open! Skating hours are 9 a.m. to 10 p.m. every day. In the event of snow, we ask that you do NOT shovel the hockey rink. This can cause berms to freeze to the ice, which means Public Works will have to close the rink to fix it. The warming house schedule is 4 to 10 p.m. on weekdays, and noon to 10 p.m. on weekends, depending on worker availability. There is also firewood for use in the firepit by the Gorecki Center.



#### **PUBLIC WORKS**

#### Winter Parking

Per ordinance, parking is prohibited on any street from 1 a.m. to 6a.m., November 1 through April 1. Please adhere to this rule to make sure our streets can be plowed thoroughly.

#### Snow, Ice, Dirt, or Rubbish

Per ordinance, all snow, ice, dirt, or rubbish must be removed from public sidewalks. The owner and/or occupant of any property adjacent to the walk has 24 hours to remove it.

#### **ROAD TESTING NOW AVAILABLE**

The Deputy Registrar is open to the public Monday through Friday 8 a.m. – 4 p.m. for both walk-ins and appointments, which can be made on our website <a href="https://www.cityofmilaca.org/registrar">www.cityofmilaca.org/registrar</a>. Cutoff time for walk-ins is 3:45 p.m. We are limiting the number of parties in the office to four so we can all stay safe, as well as keeping our doors unlocked.

If you need a question answered right away, please email us at <a href="mailto:depreg@milacacity.com">depreg@milacacity.com</a> and we'll get back to you as quickly as possible. If you need anything looked up that is not public information, you do have to come in. Otherwise please utilize the state's website to look at statuses of titles and driver's licenses. The drop box by our door can be used for tab renewals, DNR transactions, and even title transfers! The paperwork in the box is processed daily. Please fill out the provided form to go with the paperwork dropped off.



If you need a driver's license, please make an appointment as soon as you can as they do expire at midnight on your expiration date with no extensions.

Class D and CDL road tests are now offered at Milaca City Hall by DVS Examiners. Testing hours are from 9 a.m. to noon, and 12:30 p.m. to 4 p.m. Knowledge testing will also be available on the 2nd Thursday of each month from 9 a.m. - 11:15 a.m. Please note that appointments **MUST** be made via the MN DVS website (drive.mn.gov/). The Milaca Deputy Registrar is unable to answer questions or make appointments with regard to these tests. Questions can be directed to (651) 284-1234. We offer written class D knowledge tests in our office by appointment only, and it does cost \$10.00 to take it with us. We do the testing on a computer, and will read the questions out loud to those who need it.

Please be advised that if you are coming from out of state, you are required to do a written test. Allow a little extra time at your appointment if you are taking it with us. #### SIX TIPS FOR WINTER

#### **Winter Fire Safety Tips**

- 1. Install and test alarms, carbon monoxide alarms should be tested at least once a month.
- Never use an extension cord or power strip for space heaters, plug directly into an outlet.
- 3. Keep anything that can burn at least 3 feet away from space heaters, fireplace, or wood stoves.
- 4. Clean out your chimney and vents once a year
- 5. Don't leave candles unattended and never use them for emergency lighting. Have flashlights available and extra batteries.
- 6. If you have a fireplace, always use a metal or heat-tempered glass screen.

#### **Driving Tips in a Snowstorm**

- 1. Don't drive! If you don't need to go out, stay home!
- 2. Drive slowly, and accelerate and decelerate slowly.
- 3. Increase your following and stopping distance 3 times more than normal.
- 4. Don't power up hills; take your time to maintain control.
- 5. Know your brakes slow steady pressure when stopping.
- 6. Don't pass or tailgate snowplows. Same applies to emergency vehicles. Safety is more important than trying to get around them.

#### **Snowmobile Safety Tips**

- 1. Be prepared, wear the right gear, and know where you are if you need to report an accident.
- 2. Check the weather before you ride; don't get stuck in a storm.
- 3. Understand your machine and how speed and drag impacts stopping distance and control.
- 4. Slow Down! Excessive speed is the number one cause of snowmobile accidents.
- 5. Never drink and ride. Alcohol accounts for more than 70% of all snowmobile fatalities.
- 6. Keep right! Especially on hills and corners with limited visibility.
