- The Milaca City Council passed an increase to water rates. The base increased \$1.00 and the rate increased \$0.10 per 1,000 gallons of water. This increase will take effect on the February statements.

Please remember that building permits need to be completed and turned in for approval to city hall for the following:

- Roofing
- Siding
- Windows
- Addition/Alterations
- New construction of a house or any other building
- Deck
- Fence
- Finish Basement
- Fireplace
- Heating (HVAC)/Plumbing
- Signs



Failure to apply for a building permit PRIOR to construction could result in a Stop Work Order and a fine. Building permits can be applied through our website. Click on the following link: https://www.cityofmilaca.org/building-permits-and-inspections

The State of Minnesota requires that all residential building contractors, remodelers, and roofers must obtain a state contractor's license. If you are hiring a contractor for construction, they must have this license to work in the City of Milaca. Dog license renewals are due! Reminders were mailed out to dog owners who currently have their pets licensed. Please keep in mind that lack of renewal notice does not exempt you from getting a license for your canine friend. Proof of up-to-date distemper and rabies vaccinations is needed for a license. License fees are \$15 for first dog, \$15 for second dog, and \$30 for third dog.

Rec Park

The skating rink at Rec Park is officially open! In the event of snow, we ask that you do NOT shovel the hockey rink. This can cause berms to freeze to the ice, which means Public Works will have to close the rink to fix it. Winter Parking

Per ordinance, parking is prohibited on any street from 1 a.m. to 6 a.m., November 1 through April 1. Please adhere to this rule to make sure our streets can be plowed thoroughly.

Snow, Ice, Dirt, or Rubbish

Per ordinance, all snow, ice, dirt, or rubbish must be removed from public sidewalks. The owner and/or occupant of any property adjacent to the walk has 24 hours to remove it.





Deputy Registrar Notes

The Deputy Registrar is open to the public Monday through Friday 8 am – 4 pm. If you have a transaction that is going to take longer, please try to be here no later than 3:45 pm. The knowledge test is offered here on a computer in the office. It can get a bit noisy in here, so if you need to bring ear plugs, they are allowed. The test is by appointment only and the fee is \$10. Knowledge test appointments can be made on our website <u>cityofmilaca.org/registrar</u>. We try very hard to help everyone, so please be patient with us!

Filing fee increases happened for us finally! We have waited years for this as we have made very little processing driver's licenses that take up so much of our time! So try to be nice to your local offices with the increased prices, as we have waited a long time and gone through a lot to get here. Every office truly deserves it with everything we do for the state and our customers on a daily basis.

State offers Road test appointments on Thursdays. Appointments can only be made online at <u>drive.mn.gov</u> or if you need assistance, you can call the state at <u>(651) 284-1234</u>. Be aware that appointments are limited, so it may say no availability. Any questions about the road tests need to be answered by state, as we have nothing to do with them. If you need a question answered right away, please email us at <u>depreg@milacacity.com</u> and we can answer your questions. If you need anything looked up that is not public information, you do have to come in to the office due to data privacy. We also welcome everyone to utilize the drop box for tab renewals, DNR transactions, and even title transfers if completed! We check the box every day and do the work in between customers. Please fill out the provided form to go with the paperwork dropped off.

We are also finally getting our office remodel this January, so please bear with us with any changes we have going on.

We appreciate all of our customers, so thank you for trusting us to serve you! Stay safe on those snowy roads!

WINTER SAFETY TIPS

Freeze Out Winter Fires

- Keep all doors and windows that could be used for an escape route clear of snow and ice.
- Keep all vents fireplace, dryer, furnace and oven clear of snow, ice and debris.
- Never use a blow torch to thaw frozen pipes.
- Use flashlights, not candles, if you lose power.
- Keep anything that can burn at least three feet from heat sources; do not use your oven to heat your home.



Did You Know?

- Most home fires occur in the winter and peak in January.
- Each year in the United States there is more than \$2 billion in property loss due to winter home fires.
- Last year in Minnesota, 39 percent of fire deaths occurred in October, November and December.

Carbon Monoxide Alarms

- Carbon monoxide alarms should be installed within 10 feet of each sleeping room or inside each sleeping room.
- Test CO alarms monthly.
- If a CO alarm sounds and you feel ill, call 911 immediately. If you feel fine, open windows and doors and your utility company.
- Clear snow and debris from furnace, dryer, fireplace or oven vents around your home to prevent a CO buildup.

Did You Know?

- Carbon monoxide is an odorless, tasteless and invisible gas.
- Signs of CO poisoning include headache, nausea, fatigue, vomiting and disorientation.
- Cooking and heating units that burn fuel and are not properly ventilated or malfunction can be a source of CO in the home.
