AMENDMENT TO EMPLOYMENT AGREEMENT

Whereas, on December 15, 2021, the City of Milaca (Employer) and Tammy Pfaff (Employee) executed an Employment Agreement, a true and correct copy of which is attached hereto and incorporated by reference; and,

Whereas, from the period of time from January 1, 2022 to the date of the execution of this agreement, Employee has been required to work a significant number of hours above and beyond what was anticipated by the Employer and Employee when the original Employment Agreement was executed. Said work was due to issues and circumstances beyond Employee's control; and,

Whereas, Employer wishes to fairly compensate Employee for the excess work Employee was required to perform for the above-referenced time period.

Therefore, it is hereby agreed to by and between Employer and Employee that the Employment Agreement shall be amended as follows:

SALARY. Employer and Employee agree that on January 1, 2022 a salary increase will be given for a salary of \$86,985.60. There will be an annual review in November of each year at which time Employer agrees to consider an increase in compensation to the Employee dependent upon the results of the performance evaluation. In addition to the above amount, Employer agrees to pay Employee the sum of \$9,000.00 as and for fair and adequate compensation for the additional work Employee was required to perform on behalf of Employer for the time period of January 1, 2022 to the date of the execution of this agreement. This additional \$9,000.00 shall be paid to Employee in equal proportions through the normal pay periods beginning October 1, 2022 through December 31, 2022.

All other terms and provisions of the original Employment Agreement shall remain in full force and effect.
